This is an Agreement between Caryl Wolff and (Print name) _____

for Caryl to give me instruction to train my dog or puppy named _____

By signing this Agreement, I understand that:

- **THIS IS A FOUNDATION TRAINING PROGRAM** and that **further training beyond the initial lessons and/or classes may be necessary to get the desired response I want from my dog or puppy.**
- I must follow ALL Caryl's instructions and recommendations and that even if I do so, that **no guarantee of performance is implied, stated, or indicated.** I must practice with my dog or puppy every day for a minimum of two five-minute sessions as well as integrate all Caryl's suggestions into our lives.

() **GROUP CLASSES or PRIVATE/GROUP CLASSES COMBINATION** – I understand and agree to the following:

- I am enrolling in the following program consisting of _____ one-hour group classes

- The fee for this program is \$_____ payable in advance. There are no refunds, and it is nontransferable.
- I will abide by Class Policies & Regulations, set forth in a separate document and at www.DoggieManners.com.
- Caryl at her sole discretion may drop me from the class at any time for any reason.
- Although some behavior problems may be addressed in class and solutions may be offered, many behavior problems are complex and private lessons are necessary. Caryl will tell me if additional private instruction is necessary, and I will decide whether to follow her advice.

() **PRIVATE LESSONS PROGRAM** – I understand and agree to the following:

- This program consists of one two-hour and four one-hour lessons or a total of six hours of lessons.
- The fee for this program is \$_____. This amount is payable in full today, and there are no refunds.
- The initial five private lessons must be completed within three months of the date of the first lesson.
- The content of each session will be determined at that session.
- Lessons are scheduled in advance individually. If I cancel a lesson, **I must give Caryl at least 48 hours' notice of cancellation** or I forfeit that lesson. I may make only two such cancellations or I forfeit the lesson. (Initial _____)
- Any additional private lessons within two months of the last lesson will be at the rate of \$_____ per hour. Further lessons beyond that time will be at an agreed-upon rate.
- At Caryl's sole discretion, my dog or puppy may take group lessons at no additional charge.

() **OTHER PRIVATE LESSONS** _____

Payment is due at the beginning of each lesson at the rate of \$_____ for the first _____ hour(s) and \$_____ per hour or portion thereof for each succeeding lesson. **I must give at least 48 hours' notice of cancellation** for each succeeding lesson or I will pay for that lesson. (Initial _____)

If I or my dog or puppy causes property damage or injures any dog, animal or person, including Caryl, during or after the term of this Agreement, on or off the Training Premises, then I agree to pay all resulting losses and damages suffered or incurred by Caryl, her agent, and/or any other person, entity, or animal, and to defend and indemnify Caryl, her agent, and/or any other person or entity from any resulting claims, demands, lawsuits, losses, costs, or expenses, including attorney's fees.

With regard to me or anyone accompanying me at any of the Training Premises (including any adults or children whether related or not), I will defend and indemnify Caryl, her agents and employees, and/or any other entity against any claims, demands, lawsuits, losses, costs, or expenses, including attorney's fees, brought by or on behalf of any such persons.

This Agreement is binding upon Caryl and me; supersedes all prior discussions, representations, warranties and agreements between us, and expresses the entire agreement between us. Caryl and I confirm that, except for that which is specifically written in this Agreement, no promises, representations, or oral understandings have been made with regard to my dog or puppy, its training, or any other matter. Without limiting the generality of the foregoing, I acknowledge that Caryl has not represented, promised, guaranteed, or warranted that my dog or puppy can be trained, that my dog or puppy will never bite, that my dog or puppy will not be dangerous or vicious in the future, that my dog or puppy will not exhibit other behavioral problems, or that the training will last for any particular amount of time. This Agreement may be amended only in writing signed by both Caryl and me. Any remedy provided in this Agreement is in addition to any and all other remedies provided by law or equity. If any provision of this Agreement is invalid, void, or unenforceable, it will be severed and the remaining provisions shall be given full force and effect.
